Procedure for admission to BAMS/BHMS courses in all Private Institutes of the State of Haryana and UT Chandigarh (Shri Dhanvantry Ayurvedic College and Hospital, Sector 46- B Chandigarh) for Academic Session 2018-2019.

It is for the information of all the concerned that in compliance with the order of Hon'ble Punjab and Haryana High Court and High Court of Delhi, afresh online applications for BAMS/BHMS courses are invited from those candidates **who have not registered earlier (11th-15th and 24th-25th October 2018) and has not secured admission** in earlier counselling (Dated 19,20,25 & 29th October 2018) for the AYUSH Institutes located in the State of Haryana including newly permitted Baba Mastnath Ayurvedic College, Asthal Bohar, Rohtak, Gangaputra Ayurvedic College, Kandela-Jind, Seth Murari Lal Rasiwasia Ayurvedic College & Hospital Charkhi- Dadri, National College of Ayurveda, Barwala-Hisar (subject to compliant with the order of Hon'ble Punjab and Haryana High Court dated 29,30-10-2018 by the petitioner by 31.12.2018) and interim order dated 30.10.2018 in the case of Shri Ram College of Medical Science & Research Digtrota, Distt Mohinder Garh (subject to the outcome of decision in the petition no. W.P.(C) 7954/2017 and CM 17926/2017 in the High Court of Delhi) for the session 2018-19. The following shall be the afresh counselling schedule:-

Note:- 1. Already registered candidates, who have not secured admission earlier, need not to apply afresh. They will be considered in the new merit list by virtue of extension of admission date by GOI.
2. On spot registration will also be done on the day of mop up round for fresh candidates dated 15.11.2018, but these on spot registered candidates will be considered only after exhausting the previous merit lists.
3. The fees for the 1st round of counselling have to be deposited by 14-11-2018 up to 4.00 PM other wise seat allotted will be considered vacant. Fees for MOP up round counselling will be deposited on the spot at the time of counselling as per notification dated 30.07.2018 and corrigendum dated 03.10.2018 (For detail information please visit the University website www.skau.in.)
4. Fee will be accepted in the form of DD/RTGS in favour of Registrar, Shri Krishna AYUSH University, Kurukshetra.

All the eligible NEET qualified (35th percentile for General Category, 30th percentile for General PH, 25th percentile for Reserved Category Candidates) candidates are required to register themselves online through Shri Krishna AYUSH University website www.skau.in or through admission web portal hrybamsadmissions.in.
