## GENERAL TERMS & CONDITIONS FOR COUNSELLING

1. For the physical round of counselling the candidates may be called in two batches on dated 13-14<sup>th</sup> November 2018 as per the common merit list which will be displayed on University website and admission web portal on dated 12.11.2018. Hence, candidates are requested to regularly visit the website.
2. All the earlier registered candidates are advised to take new print out of their application form from the admission web portal.
3. The candidates will have to deposit the fee in the shape of demand draft payable to Registrar, Shri Krishna AYUSH University Kurukshetra at the time of Counselling itself (on the spot) or on the reporting date (14.11.2018) till 4.00 PM in the concerned college or in the University itself as mentioned above failing to which his/her admission shall stand cancelled.
4. The personal appearance of the candidates before the Admission Committee at Shri Krishna AYUSH University Kurukshetra is mandatory.
5. Any order of the Hon'ble Supreme Court/Punjab and Haryana High Court or any other Court Amendments by the State Government/Government of India, Ministry of AYUSH/CCIM shall be applicable at any stage.
6. Admissions shall be made to only those institutes which are recognized and approved for admission from CCIM/GOI/Court orders and who have obtained consent of the affiliation from the concerned University. Those Institutes which are unable to get affiliation/approval from CCIM/State Govt./University shall not be considered for counselling.
7. The candidates who will register on the spot for admission for the Mop up round on dated 15.11.2018 will be considered for admission on their merit basis only after exhausting the merit list of candidates who have registered earlier on the admission web portal.
8. Personal appearance of the candidates along with all original documents in front of admission committee in Shri Krishna AYUSH University Kurukshetra is mandatory.
9. Any candidate who fails to deposit original document along with the fee at the time of counselling will not be considered and his/her claim to admission will be forfeited and the seat shall be offered to the next candidate in the order of the merit.
10. Candidate should attain age of 17 years on or before 31.12.2018
11. All documents must be produced in original along with two sets of self-attested photocopies and four Photographs. In case the students already deposited the original document in any other institute other than AYUSH Institutes of Haryana and U.T. Chandigarh then he/she have to produce the receipt of that institute regarding documents with an undertaking to submit the original document within a stipulated time as decided by the counseling Committee.
12. If any discrepancy/false statement in the documents of the candidates found therein subsequently at any stage, his/her admission shall stand cancelled.
13. Any admissions made by any private BAMS/BHMS institutes including those under private university in the state at its own level shall not be valid and such admission shall be considered as null and void.
14. If any dispute/issue arises, in this regards the decision of admission committee shall be final.
15. In Mop up round the candidate have to deposit the fees through demand draft/RTGS on the spot at the time of counselling, so he/she is advised to bring Demand Draft as per detail below:-
  - a. In the case of admission in Private colleges = Rs.75000/-
  - b. In the case of admission in SGT University or Baba Mastnath University = Rs1.75 Lakhs in addition to Demand Draft of Rs.75000/- (Total 2.2 lacs)
  - c. For NRI category The amount of \$5000/- through demand draft/RTGS (INR rate as on date of counseling)
