### ADMISSION NOTICE FOR BAMS/BHMS VACANT/LEFT OVER SEATS SESSION 2018-19

It is for the information of all the concerned that in compliance with the order of Hon'ble Punjab and Haryana High Court, Chandigarh CWP No. 26 of 2019, afresh applications are invited for Admission on vacant seats in BAMS/BHMS Courses for the AYUSH Institutes located in the State of Haryana and recognized and permitted for admission from CCIM/GOI or by Hon'ble High Court. Shri Krishna AYUSH University Kurukshetra is conducting Centralized Counselling for admission on the basis of merit of NEET-UG 2018 (35<sup>th</sup> percentile for General Category, 30<sup>th</sup> percentile for General PH, 25<sup>th</sup> percentile for SC/BC candidates) and eligible candidates other than NEET(PCB qualifying Criteria) for the Academic Session 2018-19. Preference would be given to the NEET qualified Candidates.
