ADMISSION NOTICE FOR BHMS VACANT/LEFT OVER SEATS SESSION 2018-19

It is for the information of all the concerned that in compliance with the order of Hon'ble Punjab and Haryana High Court, Chandigarh in CWP No. 23572 of 2016 dated 08.01.2019, on the spot Counselling for Admission on vacant seats in (UG) BHMS Course and PG Homeopathy for J. R. Kissan Homeopathic Medical College, Rohtak, will be done in Shri Krishna AYUSH University, Kurukshetra on the basis of merit of NEET-UG 2018 (35th percentile for General Category, 30th percentile for General PH, 25th percentile for SC/BC candidates), eligible candidates other than NEET (PCB qualifying Criteria) and AIAPGET-2018 respectively for the Academic Session 2018-19 subject to the affiliation/permission from CCH/GOI. Preference would be given to the NEET and AIAPGET-2018 qualified Candidates.


