## GENERAL TERMS & CONDITIONS FOR COUNSELLING

It is for the information of all the concerned that in compliance with the order of Hon'ble Punjab and Haryana High Court, Chandigarh CWP No. 26 of 2019, afresh applications are invited for Admission on vacant seats in BAMS/BHMS Courses for the AYUSH Institutes located in the State of Haryana.

1. The preference would be given to candidates, who have the NEET eligibility. The students who are without NEET eligibility, if granted admission, the same would remain subject to the final outcome of the writ petition CWP No. 28442 dated 12.11.2018. Any order of the Hon'ble Supreme Court/Punjab and Haryana High Court or any other Court/ Amendments by the State Government/Government of India, Ministry of AYUSH/CCIM shall be applicable at any stage.
2. Admission shall be made to only those institutes which are recognized and permitted for admission from CCIM/GOI or as per Hon'ble Court orders and who have obtained consent of the affiliation from the concerned University.
3. The candidates will have to deposit the full fee in the shape of demand draft payable to Registrar, Shri Krishna AYUSH University Kurukshetra at the time of Counselling itself (on the spot) failing to which he or she will not be granted admission.
4. See fee details on our Shri Krishna AYUSH University, Kurukshetra website as per notification of 30.07.2018.
5. BC Category candidates who wish to avail the benefit of their category are required to produce latest income certificate issued in last 6 months from the concerned authorities.
6. Personal appearance of the candidates along with all original documents in front of admission committee in Shri Krishna AYUSH University Kurukshetra is mandatory.
7. Candidate should attain age of 17 years on or before 31.12.2018.
8. If any discrepancy/false statement in the documents of the candidates found therein subsequently at any stage, his/her admission shall stand cancelled.
9. Any admission made by any private BAMS/BHMS institutes including those under private university in the state at its own level shall not be valid and such admission shall be considered as null and void as per the Govt. Notification of 30.07.2018
10. If any dispute/issue arises, in this regards the decision of admission committee shall be final and may be appealed to the Government of Haryana/ Health & AYUSH Department.
11. Reshuffling/shifting of colleges is not allowed.
